Note 1: The rate applicable to movements from Sacatosa, Maverick County to Pearsall Station, Frio County is temporarily decreased to [U] 75.00 cents per barrel. The rate applicable to movements from Pipeline-connected Tank Batteries, Frio County to Pearsall Station, Frio County is temporarily decreased to [U] 25.00 cents per barrel. The rate decreases described in this Note 1 are being implemented as an accommodation to shippers while Arrowhead Gathering Company, LLC performs necessary repair work on its system and will be available only for a limited period of time while such repair work is being completed. Arrowhead Gathering Company, LLC reserves the right to cancel the temporary rate decreases described in this Note 1 at any time upon notice to its shippers.

**Pumping Charge:** Where pumping service is performed by Arrowhead Gathering Company, LLC an additional charge of [I] 20.88 cents per barrel will be made on all crude petroleum pumped directly into another carrier's system.

**Hand Run Gauging Fee:** There will be an additional charge of [I] 20.88 cents per barrel on gathered crude petroleum which is hand run gauged.
