Note 1: The Uncommitted Shipper Rates are applicable to any Shipper that does not otherwise qualify for the Committed Shipper Rates, as described in Note 2.

Note 2: The Committed Shipper Rates are applicable to any Shipper that has an effective transportation services agreement with Carrier, wherein the Shipper has agreed to ship, or otherwise pay for, a minimum volume of crude petroleum from one of the origin points to one of the destination points in this tariff, over a three-year period.

[N] Note 3: Once a total of 4,560,000 barrels are shipped from the origin at Dougherty Berdie Hons Hoffman Lateral Pipeline-Connected Tank Batteries, Karnes County TX, the Uncommitted Shipper Rate and Committed Shipper Rate set forth in Table One that are applicable to movements from Dougherty Berdie Hons Hoffman Lateral Pipeline-Connected Tank Batteries shall be reduced by 25.00 cents per barrel. [C] For the barrels originating from the Patsy Clark Lateral Origin, the rates set forth in Table One shall be reduced by 10.52 cents per barrel for all barrels exceeding a total of 3,285,000 barrels. For the barrels originating from the Crews Kotara Lateral Origin, the rates set forth in Table One shall be reduced by 51.53

Note 4: The Committed Shipper Rate applicable to deliveries from the Pipeline – Connected Tank Batteries in Karnes County, TX, Live Oak County, TX and Atascosa County, TX to NuStar 100 Series Tank Farm (fka Martin Terminal) (leased by STUSCO), Corpus Christi, Nueces County, TX has been temporarily decreased to encourage additional deliveries by shippers. This decreased rate is only available for a limited period and may be increased up to its previous level of [I] 170.52 cents per barrel or above by Pipeline Operator prior to the beginning of any shipment Month.

Note 5: The Committed Shipper Rate applicable to movements from Karnes City Truck Offload Terminal, Karnes County, TX to NuStar 100 Series Tank Farm (fka Martin Terminal) (leased by STUSCO), Corpus Christi, Nueces County, TX has been temporarily decreased by three cents per barrel from the rate stated in the above Table One to encourage additional deliveries by shippers. This decreased rate is only available for a limited period and may be increased up to its previous level of [I] 141.23 cents per barrel or above by Pipeline Operator prior to the beginning of any shipment Month.

Note 6: The Volume Commitment Incentive Rate is available to any shipper that is willing to make a volume commitment for movements from the listed Origins to the listed Destinations.

UNLOADING CHARGE: All shipments unloaded by tank truck into the mainline facilities under this Arrowhead Tariff No. [W] 2.18 ~~2.17~~ will be subject to a charge of eight cents [U] eight cents (\$0.08) per barrel in addition to the transportation rates named herein.
